- 6. All applicants will be asked to give consent to a police vet. It is a requirement in the Education Sector for all employees to be vetted.

 - You have paid any fines or costs

Custodial sentences include a sentence of preventative detention and corrective training. Non-custodial sentences include fines, reparation costs, community-based sentences and suspended sentences. Please note that you are not obliged to disclose convictions if you are an eligible individual but can do so if you wish.
